

Persimmon Homes – Stay Active and Good Luck Team GB competition terms and conditions

1. By entering the Competition the entrant agrees that they (and their parent / guardian if the entrant is under 18 years old), have read, understood and agreed to be bound by the Competition Information and these terms and conditions
2. The Promoter is Persimmon Homes PLC a company incorporated in England with company number 01818486 whose registered office address is Persimmon House, Fulford, York, UK, YO19 4FE.
3. To participate in the Competition, entrants must share an image or video of their Good Luck Team GB A4 poster to either their public Twitter or Instagram page with #PersimmonHomesStayActive or comment on Persimmon Homes' Facebook post, published on Thursday 17th June at 9am.
4. The Competition will commence on Thursday 17th June at 09:00. The closing date for the receipt of entries is 23:59 (GMT) on the Friday 23rd July.
5. A single prize winner from either Facebook, Twitter or Instagram will be selected by the Promoter's nominated judges from all qualifying entries. That person selected will be someone who has fulfilled the criteria in 3 above.
6. The Competition is open to individuals who are residents of the United Kingdom and aged 18 or under who are residents of [England, Scotland and Wales]. The Promoter's employees, its contractors and the families or anyone directly or indirectly connected with the Promoter are not eligible to be entrants for the Competition.
7. The Promoter assumes that by entering the Competition (and the individual warrants that) they are aged 18 or under.
