

## Terms & Conditions up to 12 months mortgage contribution- Charles Church-East Wales

1. This offer is available between 9am GMT 01/05/26 and 5pm GMT 31/05/26 (both dates inclusive) (“the **Offer Period**”) on selected Charles Church Developments and plots only in our East Wales operating company area, subject to customer status and availability. The term “**Price**” means (in these terms and conditions) the release list price for the relevant plot disregarding the cost of any extras or finishing touches You may order from Us. In these terms “**You**” means the customer(s) and applies if the relevant Charles Church is being acquired by one or more persons. “**Us**” and “**Our**” are references to Charles Church. “**The Offer**” means the offer detailed in paragraph 3 below. The provision of the Offer is strictly subject to these terms and conditions. For the avoidance of any doubt if You comprise more than one person and either or any of You withdraw from the purchase of the Persimmon home, the person(s) so withdrawing shall not be entitled to the Offer.
2. Our sales representative will let You know in writing, during the Offer Period whether or not You potentially qualify for this Offer (qualification would ultimately remain subject to these terms and conditions) . To qualify for this offer You need to have entered into a reservation agreement with Us (which includes the payment of the required reservation fee) for the specific Charles Church Home to which Our Offer relates no later than 5pm GMT 30/06/26 (time being of the essence).
3. The Offer will be calculated on the basis of the actual mortgage offer that You intend accepting (We will need to see evidence of the projected payments from your financial advisor or lending institution prior to legal completion). The Offer is that We shall “contribute” to Your mortgage (by way of an allowance on the Price (see Clause 6 below)) and this “contribution” shall be equal to the first 12 average monthly mortgage payments you will be due to make. Notwithstanding the foregoing the financial incentive available to You shall not exceed a sum equating to 5% of the Price and the maximum monthly mortgage payment to qualify for the offer shall be £2,400 (Our “contribution” shall be calculated taking into account that monthly cap)
4. You should speak to a Charles Church-recommended New Homes Mortgage Adviser to get a specific mortgage illustration for the property that you wish to buy.
5. Regardless of the Offer that We say You are entitled to receive on or prior to reservation of the Charles Church home, You will not be eligible to receive and take advantage of the Offer if You purchase the Charles Church home where any one or more of the following apply:
  - 5.1 using a buy to let mortgage product; or
  - 5.2 using the First Homes Scheme or other Discount from Market Value scheme; or
  - 5.3 using any Government Help to Buy or similar scheme; or

- 5.4 using any of Charles Church part exchange or home change scheme; or
  - 5.5 using any shared ownership or shared equity scheme; or
  - 5.6 where one or more of the purchasers is a corporate entity, LLP or partnership.
6. The Offer comprises a financial incentive that will be shown on the completion statement as a “deduction” from the completion balance when you complete Your purchase of the Charles Church home (the Offer will not be given or paid to You by any other means).
