

Terms and conditions (1)

Deposit Paid Offer & Free Upgrades

1. In this Offer “**Contract**” means the legal contract that You and We will exchange for the sale and purchase of a Persimmon home. The term includes regional equivalents (such as missive in Scotland). It does not include the reservation agreement that You and We enter into. In these terms the term “**Price**” means the purchase price for the Persimmon home as will be stated in the transfer deed or lease (or in either case regional equivalent) and in any event does not include any additional sums payable for extras fixtures and fittings and enhancements and does not take account of the Offer.
2. This offer is available on plots only in the Yorkshire region, subject to customer status and availability. In these terms “You” means the customer(s) and applies if the relevant Persimmon is being acquired by one or more persons. “Us” and “Our” are references to Persimmon. “The Offer” means the offer detailed in paragraph 4 below. The provision of the Offer is strictly subject to these terms and conditions. “We” means Us and You. For the avoidance of any doubt if You comprise more than one person and either or any of You withdraw from the purchase of the Persimmon, the person(s) so withdrawing shall not be entitled to the Offer.
3. Our sales representative will let You know in writing, during the Offer Period whether or not You potentially qualify for this Offer (qualification would ultimately remain subject to these terms and conditions). To qualify for this offer You need to have entered into a reservation agreement with Us (which includes the payment of the required reservation fee) for the specific Persimmon to which Our Offer relates no later than 08.10.26 (time being of the essence).
4. The Offer comprises a financial incentive that:
 - 4.1 is a financial contribution towards the deposit and is a sum that, regardless of the Price, shall not exceed £5,000 and
 - 4.2 will be shown on the completion statement as a “deduction” from the completion balance when you complete Your purchase of the Persimmon (the Offer will not be given or paid to You by any other means)
5. The Offer comprises a non-financial incentive comprising the provision and fitting (where appropriate) of an Integrated Fridge/Freezer, Dishwasher, Boiler Housing & Stainless Steel Splashback from Persimmon’s Finishing Touches range being available in Persimmon’s Finishing Touches brochure as at the date of reservation (up to a maximum value of £[3,500]) (the “Upgrades”) to the Persimmon home as purchased by You
 - 5.1 Any Offer or part of an Offer that does not comprise a financial incentive may not be exchanged or substituted for anything else (including a monetary sum).
 - 5.2 The provision of the Upgrades is subject to the availability of such items with Us being entitled to exchange any such fixtures and fittings with alternatives that We (acting reasonably) believe are of comparable quality and style). You accept and acknowledge that in certain circumstances the fitting of the Upgrades may not be finished by the completion date of the sale and purchase of the New Home. If this should apply then You will give Us reasonable

access to the New Home after completion to manage the fitting and delivery of the Upgrades (which We shall endeavour to achieve as soon as reasonable practicable). You shall not be entitled to any compensation or alternative product for any late fitting of the Upgrades. To qualify for the fitting of the Upgrades You must have selected them and notified Your selection to Us by the date that You enter into a reservation agreement with Us.

6. Regardless of the Offer that We say You are entitled to receive on or prior to reservation of the Persimmon home, You will not be eligible to receive and take advantage of the Offer if You purchase the Persimmon home where any one or more of the following apply:
 - a. using a buy to let mortgage product; or
 - b. using the First Homes Scheme or other Discount from Market Value scheme; or
 - c. using any Government Help to Buy or similar scheme; or
 - d. using any of Persimmon part exchange or home change scheme; or
 - e. using any shared ownership or shared equity scheme; or
 - f. where one or more of the purchasers is a corporate entity, LLP or partnership; or
 - g. for whatever reason You are or become exempt from any legal obligation to pay SDLT.
7. Persimmon shall have sole discretion to decide whether You are entitled to the Offer provided by this scheme. Persimmon reserves the right to suspend cancel or amend this Offer at any time without notice (Provided always that the terms of an Offer to an individual may not be amended where the availability of the Offer and eligibility for the Offer have been communicated in writing to that individual on or before reservation of a specific Persimmon, without prejudice though to these terms and conditions). Any suspension, cancellation or amendment will be published on Persimmon's website.
8. Notwithstanding Your potential entitlement to receive the Offer, these terms and conditions (and anything else communicated to You by Persimmon) do not give to You any period of exclusivity to purchase a particular plot and (unless a valid reservation agreement has been entered into between ourselves and remains in force and effect) We shall be entitled to enter into a reservation agreement with any third party at any time.
