

Terms and conditions (1)

Deposit Paid Offer & Flooring Upgrade Offer

1. In this Offer “**Contract**” means the legal contract that You and We will exchange for the sale and purchase of a Persimmon Homes home. The term includes regional equivalents (such as missive in Scotland). It does not include the reservation agreement that You and We enter into. In these terms the term “**Price**” means the purchase price for the Persimmon Homes home as will be stated in the transfer deed or lease (or in either case regional equivalent) and in any event does not include any additional sums payable for extras fixtures and fittings and enhancements and does not take account of the Offer.
2. This offer is available between 09/04/2026 and 09/05/2026 on Plot 56 Persimmon Homes Scarlett Mews, Tiptree, Essex, subject to customer status and availability. In these terms “You” means the customer(s) and applies if the relevant Persimmon Homes home is being acquired by one or more persons. “Us” and “Our” are references to Persimmon Homes. “The Offer” means the offer detailed in paragraph 4 below. The provision of the Offer is strictly subject to these terms and conditions. “We” means Us and You. For the avoidance of any doubt if You comprise more than one person and either or any of You withdraw from the purchase of the Persimmon Homes home, the person(s) so withdrawing shall not be entitled to the Offer.
3. Our sales representative will let You know in writing, during the Offer Period whether or not You potentially qualify for this Offer (qualification would ultimately remain subject to these terms and conditions). To qualify for this offer You need to have entered into a reservation agreement with Us (which includes the payment of the required reservation fee) for the specific Persimmon Homes home to which Our Offer relates no later than 09/06/2026 (time being of the essence).
4. The Offer comprises a financial incentive that:
 - 4.1 equates to 5% of the Price and is paid by way of a contribution to the Deposit; and
 - 4.2 is a financial contribution towards the deposit and is a sum that, regardless of the Price, shall not exceed £27,500 and
 - 4.3 will be shown on the completion statement as a “deduction” from the completion balance when you complete
 - 4.4 Your purchase of the Persimmon home (the Offer will not be given or paid to You by any other means)
 - 4.5 And the provision and fitting (where appropriate) of Flooring Upgrades to the new home reserved and to be purchased by You. The Offer cannot be substituted for anything else (including for any monetary sum).
5. The term “Upgrades” means upgrades to a Persimmon new home comprising flooring, shown as being available in Persimmon’s Finishing Touches brochure as at the date of reservation (subject to the availability of such fixtures and

fittings with Us being entitled to exchange any such fixtures and fittings with alternatives that We (acting reasonably) believe are of comparable quality and style).

6. Regardless of the Offer that We say You are entitled to receive on or prior to reservation of the Persimmon Homes home, You will not be eligible to receive and take advantage of the Offer if You purchase the Persimmon Homes home where any one or more of the following apply:

- 6.1 using a buy to let mortgage product; or

- 6.2 using the First Homes Scheme or other Discount from Market Value scheme; or

- 6.3 using any Government Help to Buy or similar scheme; or

- 6.4 using any of Persimmon Homes part exchange or home change scheme; or

- 6.5 using any shared ownership or shared equity scheme; or

- 6.6 where one or more of the purchasers is a corporate entity, LLP or partnership; or

- 6.7 for whatever reason You are or become exempt from any legal obligation to pay SDLT.

7. If You qualify for the Offer You accept and acknowledge that in certain circumstances the fitting of the Upgrades may not be finished by the completion date of the sale and purchase of the new home. If this should apply then You will give Us reasonable access to the new home after completion to manage the fitting and delivery of the Upgrades (which We shall endeavour to achieve as soon as reasonable practicable). You shall not be entitled to any compensation or alternative product for any late fitting of the Upgrades.

8. Persimmon Homes shall have sole discretion to decide whether You are entitled to the Offer provided by this scheme. Persimmon Homes reserves the right to suspend cancel or amend this Offer at any time without notice (Provided always that the terms of an Offer to an individual may not be amended where the availability of the Offer and eligibility for the Offer have been communicated in writing to that individual on or before reservation of a specific Persimmon Homes home, without prejudice though to these terms and conditions). Any suspension, cancellation or amendment will be published on Persimmon Homes's website.

9. Notwithstanding Your potential entitlement to receive the Offer, these terms and conditions (and anything else communicated to You by Persimmon Homes) do not give to You any period of exclusivity to purchase a particular plot and (unless a valid reservation agreement has been entered into between ourselves and remains in force and effect) We shall be entitled to enter into a reservation agreement with any third party at any time.
